1. This raffle is conducted by Placentia Library Friends Foundation (PLFF), located at 411 E. Chapman Avenue, Placentia, CA 92870. PLFF is a non-profit organization under Internal Revenue Code Section 501(c)(3).
2. The raffle will be conducted from 9:00 a.m., December 21, 2023 to 12:00 p.m., April 11, 2024 while supplies last.
3. Tickets will be sold at \$10.00 per ticket, at the Placentia Library District, located at 411 E. Chapman Avenue, Placentia, CA 92870. Please see a staff member at the Information Desk.
4. PLFF is NOT responsible for lost or misplaced tickets.
5. Purchaser must be 18 years or older. Minors may not purchase or have their names identified as entrants for prizes. Payment for the tickets shall be made in cash or credit card. Credit card purchases will incur a \$1.00 processing fee. All purchases are final, and no refunds will be issued.
6. Winner will be picked by public random drawing to be held at the Taylor Swift Dance Party on April 11, 2024. Winner need not be present to win.
7. Winner agrees to allow use of their name or likeness for publicity purposes without compensation.
8. If the winner does not claim the prize within 48 hours of the winning number announcement, a disqualification will result, and an alternate winner will be drawn.
